Ripley Parish Council has no objection to the licensing hours for Monday to Saturday but objects to the proposed licensing hours on Sundays and bank holidays as these do not reflect the opening hours as approved in the planning conditions of application 13/P/00180 dated 14/08/2013. Opening hours on Sundays and bank holidays are restricted to 8.00 until 20.00 to protect the amenity of the neighbouring properties

The impact of the Strategic Housing Land Availability will depend on the number of houses required in the Borough over the next 15 years. This number is not yet known.
