Ripley Parish Council objects to Planning Application 15/T/00231. There are several issues with this application, including inaccuracies with the application form itself. The trees actually <u>do</u> sit within the Conservation Area, and there is also confusion as to what height reduction the proposals entail- 2m or 4m?

Aside from these issues, there is no mention of the trees suffering from arboreal problems, and so it is assumed that the works are purely cosmetic. The developers of White Hart Meadows went to great lengths to ensure that trees were maintained wherever possible and so there can there be no good reason to carry out these proposed works.
