Proposal: Two storey side extension and single storey side extension with cat slide roof.

It was RESOLVED: That the withdrawal of the appeal regarding Pond Cottage be noted.

11/P/00645 Hilltop Farm, Staple Lane, Shere, Guildford GU5

Proposal: The use of land for the stationing of caravans for residential purposes for 2 gypsy pitches together with the formation of a new access and landscaping with utility/dayroom ancillary to that use and retention of an existing stable block.

The appeal will be dealt with by way of a Hearing. Ripley Parish Council originally made the following comments

Ripley Parish Council objects to this application because it proposes inappropriate development of Green Belt land. No very special circumstances appear to apply to override PPG 2 Green Belts. The development will be detrimental to the openness of the Green Belt and indeed the proposal to plant more trees for screening purposes will further detract from the openness of the site.

These plans are contrary to Guildford Borough Council Local Plan Policy RE2 which states" new building will be deemed inappropriate unless it is for the following purposes:

- 1. Agriculture and forestry
- 2. Essential facilities for outdoor sport and recreation, cemeteries and other uses of land which preserve the openness of the Green Belt and which do not conflict with the purposes of including land within it."

It was RESOLVED: That the above comments be sent to the Planning Inspectorate with a further reiteration of the lack of special circumstances in the application and a recommendation that the Borough Councils example of considering extending existing authorised sites be followed.

PG 45/11 PROPOSED DEMENTIA CARE HOME

Members considered the proposal for a 70 bed care home in the centre of Effingham. Special circumstances would need to be demonstrated to allow its construction as the site is within the Green Belt. (Copy attached to record minutes).
